1. Approve Legislative, Funding, & Public Affairs Committee Meeting Minutes: July 12, 2016

#### 2. Legislative Briefing (R-16-109)

Legislative/External Affairs Specialist Josh Hugg discussed the current status of AB 2444 and AB 2047, which the District support.

Ralph Heim and Russ Noack of Public Policy Advocates participated by conference call and provided additional updates on the current status of the legislation being discussed.

Mr. Hugg then provided information on legislation the District may consider pursuing for the 2017 Legislative Session.

Mr. Heim suggested including the proposed cleanup of AB 612 in the annual omnibus bill.

The committee agreed by consensus to authorize staff to pursue the cleanup language and return to the Board for action.

No committee action required.

# 3. Proposed Trail Names for La Honda Creek Open Space Preserve Phase I Public Access Trails (R-16-110)

Planner III Lisa Bankosh provided a brief overview of the La Honda Master Plan and displayed a map showing the trails proposed for naming. Ms. Bankosh described the location, terrain, and proposed names for each of the planned and existing trails.

Director Riffle inquired when hikers would have access to parking at the Driscoll Event Center.

Ms. Bankosh explained the La Honda Creek Master Plan did not include the site because the District did not own it when the Master Plan was adopted. Site planning will have to be completed before hikers have full access. Additionally, equestrians will not have access to the Sears Ranch Rd. parking lot, but hikers will. Creation of the permit equestrian lot will also discourage illegal parking on the road.
