### REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE MIDPENINSULA REGIONAL OPEN SPACE DISTRICT

President Kersteen-Tucker called the regular meeting of the Midpeninsula Regional Open Space District to order at 7:01 p.m.

**3. Appointment of the Board of Directors Standing Committee Members and Representative to Various Bodies, Including the Governing Board of the Midpeninsula Regional Open Space District Financing Authority, for Calendar Year 2026 (R-26-08)**

Board President's Recommendations: Approve the Board President's appointments to Board Standing Committees and other bodies, including the Governing Board of the Midpeninsula Regional Open Space District Financing Authority, and the compensable status for attendance at these meetings.

**4. Contract Amendment with Sicular Environmental Consulting and Natural Lands Management to authorize assignment of the contract and provide additional technical supports for the La Honda Forest Health Project (R-26-09)**

General Manager's Recommendation: Authorize the General Manager to amend the contract with Sicular Environmental Consulting and Natural Lands Management of Berkeley, California to authorize the assignment of contracted forest assessment and planning services for the La

Honda Forest Health Project to Sicular Environmental Consulting LLC (a new organized consulting entity) and provide additional technical support for a feasibility study of the Northside Road in the amount of \$37,643, bringing the total contract not-to-exceed amount to \$224,936.

**5. Award of Contract to Community Initiatives (the fiscal sponsor of Latino Outdoors) to provide Community Engagement Events for Two Years (R-26-10)**

General Manager's Recommendation: Authorize the General Manager to enter into a contract with Community Initiatives for an amount not-to-exceed \$88,000 over a two-year span to provide engaging outdoor experiences for diverse participants at various open space preserves and via online virtual presentations.

**6. Contract Amendment with Ascent Environmental for Permitting Support to Implement the Purisima Comprehensive Use and Management Plan (R-26-11)**

General Manager's Recommendations:

1. Authorize the General Manager to execute a contract amendment with Ascent Environmental for permitting support to implement the Purisima Comprehensive Use and Management Plan within the San Mateo Coastal Zone in the amount of \$60,009, bringing the contract base amount to a not-to-exceed total of \$202,184.
2. Authorize an additional 15% contingency in the amount of \$9,001 to cover unforeseen tasks and unanticipated issues beyond the current scope.
3. Authorize a separate contract allowance of \$10,000 for additional project management, application review and consultations with the permitting agency to avoid potential delays, if needed, bringing the not-to-exceed contract amount to \$262,511.

**7. Community Partnership Highlight: Vista Center for the Blind and Visually Impaired (R-26-12)**

**8. Award of Contract for Agricultural Water Development Project in La Honda Creek Open Space Preserve (R-26-13)**

Senior Capital Project Manager Paul Kvam and Senior Resource Management Specialist David Liefert presented. Assistant General Manager Brian Malone assisted in answering questions.

Director McNiven asked about the depth of the well.

Mr. Kvam responded that the well depth is approximately 250 feet, but would need to confirm with staff.

Director Holman asked about the size of the solar array panels.

Mr. Kvam stated that he would confirm the size of the solar array panels and report back the information, and that the solar array is no larger than the size of the well foundation.

**Motion:** Director Holman moved, and Director Riffle seconded the motion to authorize an award of contract to ECAST Engineering, Inc., of Oakland, CA for a base amount of \$64,001 plus a bid alternate amount of \$26,864, for a total not-to-exceed contract amount of \$90,865. Authorize a 15% contingency in the amount of \$13,630 to be reserved for unanticipated issues, bringing the total not-to-exceed contract amount to \$104,495.
