2. Grant Funding from the San Francisco Public Utilities Commission for the Highway 35 Multi-use Trail Crossing and Parking/Multimodal Access Study (R-20-101)

Planner III Aaron Peth provided the staff presentation describing the background of the San Francisco Public Utilities Commission (SFPUC) South Skyline Ridge Trail Extension project and reporting potential District concerns, including trail user safety and increased parking demand. The project scope includes analysis of the feasibility of a Ridge Trail crossing of Highway 35 and expansion of the North Ridge paring lot. Additionally, multimodal access opportunities for the parking lot will be studied. Mr. Peth described project funding, including from the SFPUC, Peninsula Open Space Trust, Ridge Trail Council, and the District.

District Clerk Jennifer Woodworth read the submitted comments into the record.

Ross Heitkamp supported the general manager's recommendation and appreciates the SFPUC is putting in nearly half the cost of the study

Josh Stivers stated e-bikes should be allowed on District bike trails.

Alex Sabo, on behalf of the Bay Area Ridge Trail supported the general manager's recommendation, which will help provide safe access to multi-use trails.
