


#### **Providing Public Comments**




### Proposed multi-year planning process

- Obtain Midpen and Town final approval




## Windy Hill Open Space Preserve





#### Timeline

- 2006: Property accepted by Midpen's Board
- 2006: Preliminary Use and Management Plan (PUMP)
- \* 2011: Property transferred to Midpen
  - Endowment
  - Conservation Easement held by POST
- 2012: PUMP Amendment
- 2012: Vision Plan
- 2014: Measure AA



#### Conservation Easement

- Granted by the Woods Family Trust to the Peninsula Open Space Trust (POST)
- Protects natural resource values of property
- Restricts future development of new buildings and infrastructure
- \* Allows low-intensity recreational uses and improvements typically offered on other Midpen preserves
- Plan must be consistent with conservation easement














## Scenic Resources













To acquire and preserve a regional greenbelt of open space land in perpetuity, protect and restore the natural environment, and provide opportunities for ecologically sensitive public enjoyment and education.

Coastside Mission: To acquire and preserve in perpetuity open space land and agricultural land of regional significance, protect and restore the natural environment, preserve rural character, encourage viable agricultural use of land resources, and provide opportunities for ecologically sensitive public enjoyment and education.

- Provide minimalist visitor amenities that complement and highlight the world-class views and open space experience.


