Documentation Review of Selected Transactions for Verification of Measure AA Expenditures

## GENERAL MANAGER'S RECOMMENDATION

Review the documentation material for the transactions selected for Measure AA expenditure verification at the January 14, 2021 Bond Oversight Committee (BOC) meeting. This review will enable the BOC to obtain reasonable assurance that expenditures incurred during Fiscal Year 2019-20 were solely for uses, purposes, and projects authorized in the Measure AA Expenditure Plan. No Committee action required.

#### SUMMARY

At their January 14, 2021 meeting, the Bond Oversight Committee (BOC) affirmed Agreed Upon Procedures to select transactions for the single land purchase for that year, 12 of the 25 highest non-land expenditures, and 7 other expenditures. The sample expenditures were selected for review to verify conformity to the Measure AA expenditure plan. Review of these selected samples will enable the BOC to obtain reasonable assurance that expenditures incurred by the Midpeninsula Regional Open Space District (District) were solely for uses, purposes, and projects specified in Measure AA.

#### DISCUSSION

The BOC has the following three responsibilities for each of the years the Measure AA general obligation tax is collected or revenues expended:

- 1. Review Plan expenditures on an annual basis to verify conformity with the Expenditure Plan.
- 2. Review the District's Annual Audit and Annual Accountability report and present the Committee's findings to the Board at a public meeting.
- 3. Review any proposed amendments to the Expenditure Plan.

For the BOC to perform responsibilities 1 and 2, verification of selected expenditures is needed to provide reasonable assurance that the expenditures incurred were for projects authorized under Measure AA.

To obtain this verification and reasonable assurance, the BOC affirmed Agreed-Upon Procedures at their meeting on January 14, 2021, to review the sole land purchase for that year, 12 of the 25 highest non-land expenditures, and 7 other expenditures, as selected by the BOC for the Fiscal Year ending June 30 2020 (FY20). The BOC also adopted procedures to be used by BOC

members when analyzing the sample expenditures, which are listed below. In addition, District staff created a cover sheet for each selected transaction to support the procedure criteria.

- Confirm that the amount listed on the expenditure report corresponds to the backup documentation.
- Verify that the date of the expenditures are within the timeframe of the fiscal year.
- Verify that the vendors included in any backup documentation are correctly listed in the spreadsheet of Measure AA expenditures.
- Verify that the project manager has signed off on the invoice payment.
- Verify that the expenditures listed in the Expenditure Report are eligible for Measure AA bond funds reimbursement.
- Confirm that the project number is listed within the correct portfolio.
- At least one of the sample selections should be an internal labor transfer of funds. Confirm that backup documentation shows the Measure AA project associated with the labor reimbursement, the staff member's pay rate, title, date work was performed, total calculation of hours being reimbursed by Measure AA funds, and project manager sign-off on the document.
- For land purchases, confirm the Board resolution and staff report to approve the purchase is included in backup documentation, and confirm the correct purchase price on the final escrow statement for the actual transaction.

Proposed purchase of the Chet Gallaway Property as an addition to El Corte de Madera Creek Open Space Preserve in unincorporated San Mateo County (Assessor's Parcel Number 081-100-050).

# GENERAL MANAGER'S RECOMMENDATIONS

- 1. Determine that the recommended actions are categorically exempt from the California Environmental Quality Act, as set out in this report.
- 2. Adopt a resolution authorizing the purchase of the Chet Gallaway property and amending the Fiscal Year 2019-20 budget accordingly.
- 3. Adopt the Preliminary Use and Management Plan, as set out in the staff report.
- 4. Withhold dedication of the Property as public open space.

#### SUMMARY

The Midpeninsula Regional Open Space District (District) has an opportunity to purchase the 1.7-acre Chet Gallaway property (Gallaway Property) for \$55,000. The following report presents a description of the Property, a Preliminary Use and Management Plan, findings of the environmental review, the purchase terms and conditions, and financial considerations. A budget adjustment/increase of \$55,000 to the Fiscal Year (FY) 2019-20 budget would be required to proceed with the acquisition.

#### DISCUSSION

In 2012, the District purchased the 58.2-acre Gallaway property and 30.78-acre Sempervirens Fund properties as additions to the western boundary of El Corte de Madera Creek Open Space Preserve (R-12-50). The Gallaway purchase included a right of first offer and right of first refusal (right to purchase) for a separate 1.7-acre property, which connects the northern portions of the Sempervirens property to the west and original Gallaway property purchase to the east. The proposed purchase of this property would further protect the north facing ridgeline and the Tunitas Creek watershed, wildlife habitat corridors, old growth redwoods, and Douglas fir forest, and may someday provide a future trail connection between El Corte de Madera Creek Open Space Preserve and Tunitas Creek Open Space Preserve. The property is within the Coastal Service Plan (Service Plan) Area, an area that was annexed into the District boundaries in 2004. This purchase advances land conservation opportunities in Measure AA Portfolio #4 for bike trail and water quality projects.

#### **Property Description**

The property is undeveloped and situated along the north-facing ridgeline above Tunitas Creek and borders the El Corte de Madera Creek Open Space Preserve to the west and east. The property is bounded by the privately owned 1,155-acre Kings Grove property to the north and a small private parcel to the south. A redwood grove, including 60 old-growth trees, is located on District land (formerly the Sempervirens Fund property) to the west. The proposed property is accessed from an existing gated dirt road via Native Sons Road. Tunitas Creek Open Space Preserve is located approximately a half mile to the west. The proposed property is characterized by densely wooded slopes with mixed evergreen forest, including redwood, Douglas fir, madrone, and tanbark oak.

#### **USE AND MANAGEMENT**

#### **Planning Considerations**

The San Mateo County General Plan designation for the proposed Gallaway Property is General Open Space, and the zoning is Resource Management-Coastal Zone (RM-CZ). Adjacent private properties to the north and south are zoned Timber Production Zone-Coastal Zone (TPZ-CZ). Nearby private properties to the southwest along Native Sons Road are zoned Resource Management-Coastal Zone (RM-CZ). In 2012, San Mateo County determined that purchase of the Gallaway properties for open space (including the proposed property) was in conformity with the County General Plan.

If purchased, the Gallaway Property will be incorporated into El Corte de Madera Creek Open Space Preserve, and a Preliminary Use and Management Plan will be implemented. When undertaken, a subsequent planning process that includes this property would analyze opportunities for natural resource management and compatible public use. Further environmental review would be prepared as needed. Subsequent planning would be in accordance with the District's Service Plan, including consultation with appropriate agencies and organizations.

#### **Preliminary Use and Management Plan**

The Preliminary Use and Management Plan (PUMP) would take effect at the close of escrow and remain effective until the PUMP is amended or a Comprehensive Use and Management Plan is approved for El Corte de Madera Creek Open Space Preserve. The PUMP represents a status quo approach to management. The Gallaway Property would be maintained in its current condition, with no changes anticipated. If changes to land use or the physical environment are proposed in the future, the plan would be subject to further environmental review and public input.

Name:	Designate the Gallaway Property as an addition to the El Corte de Madera Creek Open Space Preserve.
Public Access:	Designate the property as closed to the public. Issue hiking permits to the former owner and neighbors on a case-by-case basis, allowing use consistent with historical use patterns.

Patrol:	Regularly patrol the property utilizing existing roads.
Resource Management:	Maintain the property in its natural condition. Conduct plant and animal management activities consistent with the District's adopted Resource Management Policies as needed.
Roads and Trails:	Implement maintenance and minor erosion and sediment control measures for access roads in accordance with District and Service Plan standards.
Wildfire Fuel Management:	Implement standard District-wide fuel management and defensible space practices.
Site Safety Inspection:	No evidence of hazardous conditions was detected.
Coastal Service Plan:	Operate and manage the property in conformity with the provisions of the Service Plan and the mitigation measures adopted pursuant to the Coastal Service Plan Environmental Impact Report.
Dedication:	Withhold dedication of the property as open space at this time.
Site Condition:	No evidence of any recognized hazardous condition has been found on the property or in the 2012 Phase I Environmental Assessment.

#### **CEQA COMPLIANCE**

#### **Project Description**

The project consists of the purchase of the 1.7-acre Gallaway Property as an addition to the District's open space preserve system and concurrent adoption of a PUMP. Minor erosion and sediment control measures in accordance with District standards would be conducted along the existing access roads to prevent erosion and water quality degradation. Minor resource management activities may be conducted to control invasive plants. The land would be preserved as open space and maintained in a natural condition.

The Gallaway Property is within the boundaries of the District's Service Plan for the San Mateo County Coastal Annexation Area. The Service Plan and Final Environmental Impact Report (FEIR) incorporated policies, guidelines, and mitigations to ensure compatibility with the County General Plan and Local Coastal Plan. Actions proposed to purchase the property and implement the PUMP comply with the Service Plan and the Service Plan FEIR.

#### **CEQA Determination**

The District concludes that this project would not have a significant effect on the environment. It is categorically exempt from the California Environmental Quality Act (CEQA) under Article 19, Sections 15301, 15316, and 15325 of the CEQA Guidelines as follows:

Section 15301 exempts the repair, maintenance, or minor alteration of existing public or private structures, facilities, or topographical features, involving negligible or no expansion of use

beyond that existing at the time of the lead agency's determination. The PUMP for the Gallaway Property includes minor erosion control work as necessary along existing roads and minor restoration activities to maintain the property in a natural condition.

Section 15316 exempts the acquisition of land in order to create parks if the land is in a natural condition and the management plan proposes to keep the area in a natural condition. The PUMP for the Gallaway Property specifies that the land will remain in a natural condition.

Section 15325 exempts transfers of ownership of interests in land to preserve open space. This acquisition would transfer fee ownership of the property to the District to ensure that the open space is preserved as part of El Corte de Madera Creek Open Space Preserve.

#### **TERMS AND CONDITIONS**

The 1.7-acre Gallaway Property has a purchase price of \$55,000. The property would be purchased "as-is" and on an all cash basis.

#### FISCAL IMPACT

Land acquisitions brought before the Board for approval include a budget adjustment/increase to the adopted budget. If approved, a budget adjustment/increase of \$55,000 to the FY2019-20 budget is required.

**Current Coastside Protection Area Fiscal Considerations** 

The 1.7-acre Gallaway property is located in the District's Coastside Protection Area and within the service area of San Mateo County Fire. Under the terms of the District and County Successor Fire Agreement, the District would pay \$23.90 annually to the County, which would increase annually by 2%.

The property is not located in the La Honda-Pescadero School District; therefore, no fees are incurred under that Agreement as a result of the proposed purchase.

#### **BOARD COMMITTEE REVIEW**

As part of the original Gallaway purchase, the right to purchase the 1.7-acre Gallaway Property was reviewed by the Real Property Committee (RPC) on April 24, 2012, and approved at the Board Meeting on May 23, 2012 (R-12-50). In addition, as part of a comprehensive review of District-held rights to purchase property, the 1.7-acre Gallaway Property was reviewed by the RPC on February 28, 2017 and reaffirmed by the full Board on April 26, 2017 (R-17-44).

#### **PUBLIC NOTICE**

Public notice was provided as required by the Brown Act. A copy of this agenda was mailed to property owners of land located adjacent to or surrounding the subject property and the Coastside Protection Area interested parties mailing list.

#### NEXT STEPS

Upon approval by the Board of Directors, staff will proceed with close of escrow for the Gallaway Property purchase and will undertake the next steps identified in the Preliminary Use and Management Plan contained in this report.

The Board of Directors of Midpeninsula Regional Open Space District does hereby resolve as follows:

**SECTION ONE.** The Board of Directors of Midpeninsula Regional Open Space District (District) does hereby accept the offer contained in that certain Purchase and Sale Agreement with Chetwynd Howard Gallaway, and the Midpeninsula Regional Open Space District, a copy of which purchase agreement is attached hereto and by reference made a part hereof, and authorizes the President of the Board of Directors, General Manager, or other appropriate officer to execute the Agreement and all related transactional documents on behalf of the District to acquire the real property described therein ("the Gallaway Property").

**SECTION TWO**. The Board of Directors of the Midpeninsula Regional Open Space District authorizes the expenditure of \$55,000.00 covering the purchase of the Gallaway Property, including a deposit of \$5,000.00.

**SECTION THREE.** The General Manager, President of the Board of Directors, or other appropriate officer is authorized to execute a Certificate of Acceptance and the Grant Deed on behalf of the District.

**SECTION FOUR.** The Board of Directors of the Midpeninsula Regional Open Space District authorizes amending the Budget and Action Plan for the Midpeninsula Regional Open Space District for Fiscal Year (FY) 2019-20 by increasing the Measure AA Fund Capital budget in the amount of \$55,000.00. Except as herein modified, the FY 2019-20 Budget and Action Plan, Resolution No. 19-15 as amended, shall remain in full force and effect.

**SECTION FIVE.** The General Manager or the General Manager's designee is authorized to provide notice of acceptance to the seller and to extend escrow if necessary.

**SECTION SIX.** The General Manager or the General Manager's designee is authorized to expend up to \$3,000.00 to cover the cost of title insurance, escrow fees, and miscellaneous costs related to this transaction.

**SECTION SEVEN.** The General Manager and General Counsel are further authorized to approve any technical revisions to the attached Agreement and documents, which do not involve any material change to any term of the Agreement or documents, which are necessary or appropriate to the closing or implementation of this transaction.

    - (a) The Contractor shall provide 120 person-hours vegetation management techniques that include <u>only manual treatment methods</u>. Manual treatment methods include, but are not limited to, digging out species using weed wrenches, shovels, pick-axes, or similar tools.

- (b) Non-viable vegetative matter may be disposed of on-site in a location agreed upon by the contractor and the District. Contractor must remove and dispose of any viable seed or viable vegetative matter at their own cost.
- (c) Target species are all Cal-IPC rated weeds moderate or higher, have a Cal-IPC alert (not including cultivar trees or annual non-native grasses) and/or Coyote Brush (*Baccharis pilularis*). The District's Integrated Pest Management Coordinator shall determine which species to directly target.
  - (i) See <u>https://www.cal-ipc.org/plants/inventory/</u> for more information.
- (d) Contractor shall treat all target species so that no greater than 5% absolute cover for each species is present within the 1.09-acre "Invasive Species Abatement Zone." The "Invasive Species Abatement Zone" is the Primary Site (2.32 acres) less "Area 1" (0.71 acres) and "Area 2" (0.52 acres) (see Attachment A: Project Site Map) and Auxiliary Site (1.14 acres).
- (e) Known species on site include:
  - (i) Baccharis pilularis (coyote brush)
  - (ii) Carduus pycnocephalus (Italian thistle)
  - (iii)Centaurea solstitialis (Yellow starthistle)
  - (iv)Conium maculatum (Poison hemlock)
  - (v) Dittrichia graveolens (Stinkwort)
  - (vi)Genista monspessulana (French broom)
  - (vii)Holcus lanatus (Common velvet grass)
  - (viii)Hypericum perforatum (Klamathweed)
  - (ix)Lathyrus odoratus (Common sweet pea)
- (f) Term: The contractor may start work on this Task once Task 1.1 has been completed as well as Task 1.3 has commenced and shall be finished prior to any below tasks are implemented.
- (2) Task 2.2 Cultivar Tree Removal
  - (a) Non-native, non-local, and/or Cultivar trees within the 2.32-acre Project Site so that the stump is cut to contour within 2 inches of the grade or below the lowest branch, whichever is lower. Contractor shall use industry standards.
    - (i) Trees larger than 24" DBH or great shall remain in place.
  - (b) All material shall be chipped and spread onsite at location of cultivar tree removal or blown into forest understory and not on established vegetation, roads, or trails. Stash that is either 2" in diameter or 4' in length shall be chipped.
  - (c) Native tree species shall remain in place.
    - (i) If the contractor believe a native tree poses a safety risk, contractor will discuss with the District's Project Manager or his/her designee. The decision to remove a native tree is at the sole discretion of the District.
  - (d) Term: The contractor shall start work on this task no earlier than September 2, 2019, but shall be finished by October 15, 2019.
- iii. Element 3 Installation of Mitigation Basins

- (1) Task 3.1 Preparation of Mitigation Basin Soils
  - (a) Contractor shall coordinate with the District's Project Manager on mitigation basin planting locations.
    - (i) Fifteen (15) tree mitigation basins will be installed within the Auxiliary Site
    - (ii) Forty-five (45) tree mitigation basins will be installed within the Primary Site.
  - (b) Contractor shall improve the drainage of the area in which the sixty (60) tree mitigation basins are to be installed by first thoroughly loosening the top 10 inches of soils surround the basin locations with a minimum of a four (4) foot diameter.
    - (i) No clumps of compacted soil larger than 12 inches in diameter shall remain.
    - (ii) Fifty percent of the soil shall be in clumps 6 inches or smaller.
  - (c) The following soil amendments shall then be thoroughly blended with the top 6 inches of soil to form a homogenous layer:
    - (i) Sulfur-Coated Urea (43-0-0), 0.8 ounces per mitigation basin
    - (ii) Steamed Bone Meal (3-15-0), 0.8 ounces per mitigation basin (iii)Calcium Carbonate Lime, 5.0 ounces per mitigation basin
  - (d) Once the soil amendments have been thoroughly blended, the tree mitigation basins shall be compacted at least 100 PSI, but no greater than 200 PSI compaction. District staff will measure the compaction at each mitigation basin with an Agratronix Soil Compaction Tester Model 08180, or comparable implement.
- (e) Deadline to Complete Task: October 31, 2019, but prior to below tasks
- (2) Task 3.2 Mitigation Basin Installation
  - (a) Contractor shall install sixty (60) mitigation basins. The District will supply the seeds. The District will be harvesting seeds late summer/early fall and expects to have the seed ready for planting by October 31, 2019 or sooner.
  - (b) Seeds to be planted may one or all of the following species
    - (i) California black oak
    - (ii) California buckeye
    - (iii)Coast live oak

(iv)Pacific Madrone

- (c) Contractor shall request seed no earlier than 48 hour prior to installation of the mitigation basin.
- (d) Prior to planting, the contractor shall remove all debris within a 3-foot diameter of the planting basin and hollow out a planting hole fist deep and wide in loose soil.
- (e) Contractor shall place 3 seeds of the same species on their side in the hole, cover with soil to grade and firmly pat down.
- (f) Contractor shall install Tubex Shrubshelters, Plus Range (2.5' height) centered on the planted seeds. Contractor shall insure that each installed Tubex Shrubshelter is in good condition and securely attached to wooden stakes with the bottom edge covered by soil (see *Attachment E: Tubex Shrubshelters Installation*).

- (g) Contractor shall install a mulch layer of chipped cultivar tree 3 to 5inches deep in an area of 3-foot diameter around each tree shelter.
- (h) Contractor shall provide and water each basin with one (1) gallon of water.
- (i) Each tree shelter shall have a 7/8" x 3" double-face aluminum tag attached with a basin code embossed directly on the tag.
  - (i) The basin code will be the "BCR-" followed by the basin number.
  - (ii) The mitigation tracking sheet (see *Attachment F: Mitigation Tracking*) will be filled out that includes:
    - 1. Basin code
    - 2. Species
    - 3. Date installed
- (j) Term: Deadline to complete is November 15, 2019
- *iv.* Element 4 Additional Cultivar Tree Treatment
  - Cultivar Trees located within the auxiliary site location, as designed by the District's Project Manager, shall be directionally felled and the stump cut to contour within six (6) inches of the grade or below the lowest branch, whichever is lower. Contractor shall use industry standards.
  - (2) Felled tree shall be limbed and limbs to be pilled under existing native brush.
  - (3) Contractor shall cut piled limbs so that no limbs are above existing brush.
  - (4) Felled tree trucks shall be bucked to where the majority of the truck is in contact with the surface of the ground.
  - (5) Exceptions
    - (a) Trees larger than 24" DBH or great shall remain in place.
    - (b) Native tree species shall remain in place.
      - 1. If the contractor believe a native tree poses a safety risk, Contractor will discuss with the District's Project Manager or his/her designee.
      - 2. The decision to remove a native tree is at the sole discretion of the District.
  - (6) Term: The contractor shall start work on this task no earlier than September 2, 2019, but shall be finished by December 15, 2019.

# AGREEMENT FOR SALE OF MITIGATION CREDITS

This Agreement is made and entered into this 16th day of July, 2019 by and between Keech Properties, LLC ("Sponsor"), and Midpeninsula Open Space District (Project Proponent), as follows:

## RECITALS

A. The Sponsor has entitlements to the San Francisco Bay Wetland Mitigation Bank (Bank), located in Redwood City, San Mateo County, California; and

B. The Sponsor has been authorized by the San Francisco District of the U.S. Army Corps of Engineers (USACE) and the Region 9 of the U.S. Environmental Protection Agency (USEPA), and has received the approval of these agencies to operate as a Mitigation Bank with credits available for sale; and

C. The Bank has been authorized by the USACE and USEPA pursuant to a Mitigation Bank Enabling Instrument (BEI) dated February 2011 and

D. Project Proponent is seeking to develop the Bay Trail Connection at the Ravenswood Open Space Preserve Project, which would unavoidably and adversely impact waters of the United States thereon, and seeks to compensate for the future loss of Waters of the United States or habitat by purchasing compensatory credits from the Bank; and

E. Project Proponent desires to purchase from Sponsor and Sponsor desires to sell to Project Proponent 0.05 credits (acres) of Wetland Creation credits.

## NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

1. Sponsor hereby sells to Project Proponent and Project Proponent hereby purchases from Sponsor 0.05 credits of Wetland Creation for the purchase price of \$75,000. Upon payment, Sponsor will then deliver to Project Proponent an executed Bill of Sale in the manner and form as attached hereto. The purchase price of \$75,000 for said credits shall be paid by check payable to Keech Properties, LLC, or by wire transfer of funds according to written instructions by Sponsor to Project Proponent.

2. The sale and transfer herein is not intended as a sale or transfer to Project Proponent of a security, license, lease, easement, or possessory or non-possessory interest in real property, nor the granting of any interest of the foregoing.

3. Project Proponent shall have no obligation whatsoever by reason of the purchase of the compensatory credits to support, pay for, monitor, report on, sustain, continue in perpetuity, or otherwise be obligated or liable for the success or continued expense or maintenance in perpetuity of the credits sold, or of the Bank. As required by law, Sponsor shall monitor and make reports to the appropriate agency or agencies on the status of any compensatory credits sold to Project Proponent. Sponsor shall be fully and completely responsible for satisfying any and all conditions placed on the Bank or the compensatory credits by all state or federal jurisdictional agencies. Sponsor hereby shall indemnify Project Proponent of and from all such liabilities and obligations.

4. Project Proponent must exercise his/her/its right to purchase within 90 days of the date of this Agreement. After the 90-day period, the Agreement shall become null and void.

5. Upon closing of this sale, the Sponsor shall (i) complete the payment receipt form attached hereto and (ii) submit the completed payment receipt to the Project Proponent.

# GENERAL MANAGER'S RECOMMENDATION

Authorize the General Manager to enter into an agreement to purchase 0.050 acres of wetland creation credits for \$75,000 with the San Francisco Bay Wetland Mitigation Bank to mitigate for wetland impacts resulting from the Ravenswood Bay Trail Project.

#### SUMMARY

The Ravenswood Bay Trail Project (Project) (MAA 02-002) will close a critical 0.6-mile gap in the San Francisco Bay Trail, linking Ravenswood Open Space Preserve (Preserve) with University Avenue in East Palo Alto and Menlo Park. The Project is located adjacent to and within the baylands, a sensitive habitat area that is highly regulated. The Project was designed to minimize impacts; however, the Project will result in some unavoidable impacts to wetlands. A Mitigation and Monitoring Plan (MMP) was prepared to describe this mitigation approach to support the permit applications for the Regional Water Quality Control Board (RWQCB), U.S. Army Corps of Engineers (USACE), San Francisco Bay Conservation and Development Commission (BCDC), and U.S. Fish and Wildlife Service (USFWS). The RWQCB, USACE, and USFWS have conditioned their project permits to require the Midpeninsula Regional Open Space District (District) to fully mitigate all project impacts, including the implementation of wetland enhancement and revegetation activities and the purchase 0.050 acres of tidal wetland creation credits from the San Francisco Bay Wetland Mitigation Bank at a cost of \$75,000. The budget includes sufficient funds for the recommended action.

#### DISCUSSION

The Ravenswood Bay Trail Connection is a 1.3-mile trail construction and repair project that includes closing a 0.6-mile critical gap in the existing Bay Trail system. The project consists of an asphalt trail with decomposed granite shoulders, wood boardwalk and a prefabricated steel bridge. Although project impacts on habitats under the jurisdiction of USACE, RWQCB, BCDC and species under the jurisdiction of USFWS have been minimized to the greatest extent possible, the project will result in minimal permanent and temporary impacts to wetlands due to the project's construction.

To mitigate for these impacts, an MMP was prepared by the District's environmental consultant, H.T. Harvey & Associates, in consultation with the permitting resource agencies. The MMP details the overall mitigation approach and describes how enhanced habitats will be established, maintained, and monitored, along with standards for success and the required course of action if mitigation goals are not achieved. Habitat impacts will be mitigated concurrently with project impacts through a combination of on-site habitat enhancement to benefit the salt marsh harvest mouse and California Ridgway's rail and purchase of wetland creation credits.

While the majority of mitigation provided by the project will enhance existing wetlands and waters, the permanent loss of 13 square feet of wetlands due to the placement of the boardwalk piers is conditioned to be mitigated at a ratio of one to one through the purchase of compensatory credits at the San Francisco Bay Wetland Mitigation Bank (Bank) to fulfill requirements of the RWQCB's no-net-loss policies. The Bank utilizes mitigation funds to create tidal wetlands within privately owned land in Redwood Shores, CA. The minimum acreage available for purchase is 0.050 acres, or 2,178 square feet. Therefore, the project is ultimately creating a net gain of 2,165 square feet of wetlands within the baylands. The cost for purchasing this wetland creation credit through the Bank is \$75,000.

## FISCAL IMPACT

The Fiscal Year (FY) 2019-20 adopted budget includes \$1,976,760 for the Ravenswood Bay Trail Project (MAA02-002). There are sufficient funds in the project budget to cover the recommended action.

If approved, and once all project approvals have been secured, the General Manager will enter into a purchase agreement for \$75,000 with the Bank to purchase 0.050 acres of wetland creation credits to mitigate for wetland impacts resulting from the Ravenswood Bay Trail Project.
