1. Exterior Banners for 5050 El Camino Real (R-21-70)

Public Affairs Manager Korrine Skinner provided an update on the project and reported the Board's previous direction to approve aluminum panels for the exterior of the building and these aluminum panels are already a part of the construction contract approved by the Board of Directors. Alternative options for the exterior panels were presented as part of the interpretive plan and included metal cutout panels. If metal cutout panels are preferred, then this will incur additional costs and a time delay for the project.

The Board expressed support for using the previously approved aluminum banners due to the cost savings and ability to keep the project on schedule.

Director Siemens spoke in favor of the aluminum panels because they will allow for color to be incorporated into the panels.
