Prioritization Criteria for Measure AA Projects

GENERAL MANAGER'S RECOMMENDATION

Review, update if needed, and affirm Measure AA project prioritization criteria, including the weighting and project screening methodology.

SUMMARY

Following the passage of Measure AA (MAA) in 2014, the Midpeninsula Regional Open Space District (District) Board of Directors (Board) approved prioritization criteria and screening methodology to evaluate and identify high priority MAA projects for inclusion in a five-year project list. This five-year MAA project list is then used by staff to inform the development of the proposed annual Capital Improvement and Action Plan (CIAP) for Board consideration (R-14-114). In February 2018, the Board reviewed and updated the prioritization criteria and adopted the next MAA Project List for Fiscal Years (FY) 2019 through 2023 (R-18-13). Significant progress has been made on delivering high priority MAA projects. To proceed with developing the next (FY 2023 through 2025) CIAP, the five-year MAA Project List (FY 2024 through 2028) must first be updated. Reconfirming the MAA project prioritization criteria is the first step of the process.

BACKGROUND

Project Prioritization Criteria

Measure AA calls for the implementation of the Top 25 Portfolios identified through the Vision Plan process over the course of 30 years. Each portfolio includes multiple priorities and many projects supporting the priorities. Successful implementation of MAA project relies in part on careful planning and well-coordinated efforts that appropriately time the initiation and completion of each MAA project. As such, following the passage of MAA on June 3, 2014, the District developed comprehensive project prioritization criteria along with weighting and a project screening methodology to guide decisions about project implementation timing. On February 1, 2018, as part of the annual Board retreat, the Board reviewed and updated the project prioritization criteria to include a new criterion under Tier Three to support sustainable agriculture with an emphasis on the San Mateo Coast. The criteria remain unchanged as of 2018 and is provided below (please also refer to Attachment 1 for added details):

- Tier One Criteria (essential)
 - o Immediate public safety concern regarding District facilities and infrastructure
 - o Existing or prior legal or formal commitment
 - o Existing deadline within 1-5 years
- Tier Two Criteria (2 points)
 - o Project underway
 - Quick implementation (2 year or less)
 - Need for timely action
- Tier Three Criteria (1 point)
 - o Broad geographic distribution
 - o Diverse public benefit
 - o High beneficial impact for public use and recreation
 - o High beneficial impact for natural resources
 - o Partnership opportunity
 - Support sustainable agriculture

Tier One criteria are weighted as "Essential", reflecting the need for quick or timely implementation for reasons such as public safety concerns, legal and formal commitments, and grant funding deadlines. Projects identified as Tier One would automatically be added to the 5-year implementation schedule. Tier Two Criteria focus on the project delivery timeline as it is critical to demonstrate to the public a swift delivery of Measure AA projects. Projects already underway, can be implemented within 2 years or less, or at risk of loss of opportunity if timely action not taken would receive twice as much weight as Tier Three projects. Tier Three Criteria capture values important to the District, including geographic equity, inclusion, natural resources protection, public access, partnerships, and supporting agriculture.

Using these prior Board-approved project prioritization criteria, the District developed a five-year MAA project list and projects were incorporated into annual work plans based on available budget and staff resources. The project list was also used to inform other critical components of Measure AA implementation, such as the timing and amounts for the issuance of bonds and future staffing projections. The MAA Five Year Priority Project List for FY19 through FY23 was approved by the Board on March 15, 2018 along with an Optional Project List for projects that did not rate as high in priority but could be considered for inclusion in future CIAPs if resources were available.

Measure AA (MAA) Five-Year List Progress

The Board-approved MAA Five-Year Project List for FY19 through FY23 includes 53 projects that should be started but not necessarily completed within the five-year timeframe (refer to Attachment 2 for a detailed status of each project). As of June 30, 2021, 15 items have been completed, 34 items are in progress, and four (4) have not yet begun. Of these four, two projects are planned to begin in FY22 or FY23 and of the remaining two (listed below) one is proposed to be cancelled and one deferred past FY23:

• Cancelled -- MAA09 - Road & Trail Projects - Realignment of the Charquin Trail: Staff reassessed this site and determined that it is in a relatively stable configuration (no longer actively eroding) and no longer a major contributor to downstream erosion. Although an adjacent and naturally occurring landslide has been identified as a source of sediment, designing and installing a geotechnically stable fix for the landslide appears to be notably expensive with no guarantee of effectiveness. Instead, staff recommends shifting

attention to other higher priority projects, including other projects that protect and enhance water quality and fish habitat.

• Deferred -- MAA17 - Upper Stevens Creek Trail - Complete Trails Master Plan (includes environmental review, design and construction plans in partnership with Santa Clara County Parks): deferred to FY24 or later given insufficient capacity and resources by both partner agencies to pursue at this time. This project is dependent on partner engagement to complete.

Measure AA Optional Project List Progress

The Board-approved 2018 Optional Project List includes 15 projects. Some progress has been made on these projects and details are provided in Attachment 3.

DISCUSSION

As part of the FY22 Budget and CIAP development process in December 2020, staff informed the Board that the District is moving toward developing a true multi-year CIAP as it will best assist the District in prioritizing projects, setting timing goals, and anticipating eligible projects for potential grant funding. A multi-year CIAP will also improve the District's financial planning and staff growth projections as future revenues and staffing needs are evaluated against planned funding allocations for capital projects. With the goal of eventually arriving at a true three to five-year CIAP, staff expanded the FY22 CIAP by one year to serve as a true two-year CIAP with a complete project list for FY22 and FY23. The FY23 CIAP will add one more year, arriving at a three-year CIAP with a project list for FY23, FY24, and FY25. Recognizing that MAA projects are a significant component of the annual workplan, the District will be well served in updating its MAA Five-Year Prioritization Project List to inform the development of future CIAPs.

At the September 8, 2021 Board meeting, the Board will have an opportunity to review and update, if necessary, the MAA project prioritization criteria. Upon Board approval of the criteria, staff will assemble a preliminary project list that includes MAA Projects already underway (i.e., not yet fully completed), MAA projects remaining on the Optional Project List, and new potential projects to fulfill the commitments under the MAA Portfolio Priorities. Board members are welcome to offer MAA eligible project suggestions through the end of September for inclusion and evaluation as part of this process. Once the preliminary list is established in the fall, staff will apply the newly approved criteria and weighting methodology to develop a project prioritization list. The Board is scheduled to review the proposed project prioritization list at its first annual retreat as part of the FY23 budget development process in December 2021. After Board approval of the five-year project list, staff will incorporate priority projects in the proposed multi-year CIAP, which is reviewed annually by both the full Board and Action Plan and Budget Committee (ABC) in the spring and then adopted by the full Board in June.

FISCAL IMPACT

Review and affirmation of the Measure AA Project Prioritization Criteria has no direct fiscal impact. However, these actions will drive the development of future multi-year CIAPs and Budgets.

NEXT STEPS

The outcome of the September 8 Board meeting will guide the development of the MAA Five-Year Project List for FY24 to FY28 and the FY23 Budget and Action Plan, including the 3-year CIAP. Staff will assemble a preliminary project list with input from the Board and apply the newly approved criteria and weighting methodology to develop a project prioritization list, including a new draft Five Year MAA Project for FY24 through FY28.

The Board is scheduled to review the draft MAA project list at its first annual retreat as part of the FY23 budget development process in December 2021. At the retreat, the Board will receive a progress update on Measure AA commitments, including completion percentage for each Measure AA portfolio as measured by both the number of priorities completed per portfolio and the amount of funding allocation expended to date. As part of the update, the Board will also receive the "Portfolio Progress Indicators" moon-charts used in the Measure AA Bond Annual Accountability Report, which offer another view on the progress of each portfolio element and the number of remaining priorities under each portfolio. The information will provide context as the Board review the project prioritization list.

After Board approval of the five-year project list, staff will incorporate priority projects in the proposed multi-year CIAP, which is reviewed annually by both the full Board and Action Plan and Budget Committee (ABC) in the spring and then adopted by the full Board in June.
