# GENERAL MANAGER'S RECOMMENDATIONS



- 1. Adopt Resolutions appointing in lieu of an election the following unopposed candidates to the Board of Directors of the Midpeninsula Regional Open Space District for the 2025-2028 term:
  - J. Edmond (Jed) Cyr, Ward 3 Director
  - Curtis R. (Curt), Riffle, Ward 4 Director
  - Zoe Kersteen-Tucker, Ward 7 Director
- 2. Approve the Certificates of Appointment.

#### **SUMMARY AND DISCUSSION**

The Midpeninsula Regional Open Space District (District) was scheduled to hold a General District Election on November 5, 2024 for the purpose of electing one (1) member, for Wards 3, 4, and 7 to the District Board of Directors (Board). Only one person was nominated for each ward. California Public Resources Code Section 5532(e) provides that the Board shall appoint unopposed candidates who have been nominated. Section 5532(e) specifies that the Board shall make the appointment(s) and that the person(s) appointed shall qualify and take office and serve exactly as if elected for office. The Board adopted Resolution No. 24-13 at the June 12, 2024 regular meeting (R-24-70) authorizing the Registrars of Voters of Santa Clara and San Mateo Counties not to list any unopposed candidates for the November 5, 2024 election according to Board Policy 1.07 (Board Elections).

Jed Cyr is the unopposed candidate nominated for the position of Director – Ward 3.

Curt Riffle is the unopposed candidate nominated for the position of Director – Ward 4.

Zoe Kersteen-Tucker is the unopposed candidate nominated for the position of Director – Ward 7.

In accordance with the provisions of California Public Resources Code Sections 5532(f) and (g), certificates of election shall be issued, and the Oath of Office shall be administered within 30 days of the appointment, and at least 15 days before the start of the term. The Directors' terms will begin on January 6, 2025.
