Contract Amendment for Construction Services with SAE Consulting Engineering of San Jose, California for the Sierra Azul Ranger Housing Project

# GENERAL MANAGER'S RECOMMENDATIONS



Authorize the General Manager to execute a contract amendment with SAE Consulting Engineering of San Jose, California to provide additional construction services for the Sierra Azul Ranger Housing Project in the amount of \$21,693, bringing the total contract to a not to exceed amount of \$772,581.

### **DISCUSSION**

The Midpeninsula Regional Open Space District's (District) contractor, SAE Consulting Engineering (SAE), is completing construction services for the Ranger Housing Project (Project) located in Sierra Azul Open Space Preserve. Construction began September 2024 and is scheduled to be completed by June/July 2025. During the permit review process, the Santa Clara County Department of Environmental Health notified the District that the existing septic leach field did not meet current County requirements, and a new leach field would need to be installed. SAE has submitted a reasonable fee proposal for this work in the amount of \$51,693. Staff reviewed two additional quotes for the same work and confirmed that SAE provided the lowest price. The original contract includes an allowance of \$30,000 to make upgrades to the septic system; however, the extent of the repairs required by the County exceeds the anticipated amount. There is not sufficient contingency to cover the additional costs for the septic system repair, thus the need for a contract amendment.


