Contract Amendment for Construction Special Inspection Services with BKF Engineers for the Prospect Road Culvert Replacement Project in Fremont Older Open Space Preserve

GENERAL MANAGER'S RECOMMENDATION Selection



Authorize a contract amendment in the amount of \$43,775 with BKF Engineers of Redwood City, California to provide special construction inspection services for the Prospect Road Culvert Replacement Project (Project), bringing the existing contract to a new not-to-exceed total amount of \$138,034.

DISCUSSION

An existing perched culvert running underneath Prospect Road in Fremont Older Open Space Preserve (Preserve) was significantly damaged during the large winter storm events of 2022/2023 (Attachment 1). The Midpeninsula Regional Open Space District (District) entered into contract with BKF Engineers (BKF) on December 13, 2023 to evaluate the damaged culvert and develop construction documents for the repair and stabilization of the culvert and creek channel. The repairs consist of extending the culvert pipe to its original length, constructing a new headwall/footing, completing asphalt road repair above the culvert, and stabilizing the embankment. A Santa Clara County (County) Building Permit was issued for the Project on April 23, 2025. The Building Permit contains required special inspections, testing, and reporting for the construction work that fall outside of BKF's original scope of work. A contract amendment is required to add these additional services to BKF's contract and address the County building permit conditions. This work was not previously included in BKF's fee because the inspection type and frequency were not known until permitting was completed. Construction is scheduled to begin in August and be completed by the end of October 2025.

Scope of Work Under the Proposed Amendment:

BKF shall provide the following services and deliverables:

- Provide Special Inspections and Testing required by the County Building Permit for:
 - o Reinforcing steel
 - Concrete
 - o Soils
- Provide laboratory reports and inspections to the County Development Services Division

• Provide a project closeout statement to the County confirming that all items were completed per plans and County Building Permit requirements.

PROCURMENT PROCESS AND SELECTION

BKF was originally selected through a request for proposals/qualifications (RFPQ) process. On October 13, 2023, staff issued the RFPQ via Periscope, posted the RFPQ on the District's website, and sent direct emails to a list of qualified firms. An optional pre-proposal site tour was held on October 26, 2023, attended by representatives from 3 firms. The following firms submitted proposals by the November 9, 2023 deadline.

The proposals were evaluated using criteria outlined in the RFPQ, including quality of the proposal, implementation approach, and implementation expertise. A consultant selection panel comprised of three staff from Engineering & Construction reviewed the proposals on November 9, 2023 and, based on scoring, BKF was determined to be the best consultant for the Project.


