II. BOARD BUSINESS

1. **Agenda Item** #1 – Board Workshop for Mount Umunhum Radar Tower Options (R-12-75)

Acting General Manager Ana Ruiz welcomed the Board and public to the meeting and introduced Cathy Hyde, Constituent Services Director from Congressman Mike Honda's office. Ms. Hyde read a statement from Congressman Honda into the record.
